INTERIM SUPERINTENDENT'S REPORT

Dr. Alvarez reported in-person instruction this week is going well with the District continuing to make a concerted effort to keep students and staff safe. He noted there are more families choosing remote-only instruction for a variety of reasons; currently over a quarter of students are remote-only learners.

He acknowledged that parents and staff are wondering what's going to happen after the Holiday Recess. He advised that as has been the case throughout the pandemic, the District will review the data as it applies to River Vale and the surrounding districts and make a decision as close as possible to the January start date. Pascack Valley Superintendents are actually planning to meet on December 31 to review the latest CALI report and make a determination at that time.

In other matters, he reported administrators are tracking the pending snow storm and will make a decision on Wednesday morning regarding what the rest of the week will look like. He confirmed that predictions are in the range of 12 to 18 inches of snow, with the storm beginning mid-afternoon on Wednesday and lasting through midday on Thursday.

He stated that in spite of all the challenges, the District is conducting business as usual--teacher observations, emergency management drills, curriculum development, diversity committee work and referendum planning all continue. He noted that the District continues to make progress on a number of fronts.
