The Board also reminds all members of the public that while it subscribes, without reservation, to the principle of keeping the community informed, by policy and law, it cannot allow public discussion of personnel matters nor can trustees comment on any current or pending litigation. If a matter concerning an employee of the River Vale School District is of interest or concern to a resident, the matter should be referred to the responsible building principal or the Superintendent of Schools by telephone, letter or email.

Mr. Arthur White, 641 Cobh Road: Mr. White asked where on the website the changes to the District policies are listed?

Ms. Ippolito, School Business Administrator/Board Secretary, responded that they are the final product and that moving forward the changes will be posted.

**SUPERINTENDENT'S REPORT**

Mrs. Signore reported that our summer learning academy is in its final week of the program. This program was designed to help build students' confidence after a challenging year. She noted there was strong participation with almost 150 students enrolled in the program. The feedback received was positive from both families and staff.

She noted the administrative team has been meeting throughout the summer and following the latest covid-19 developments and guidance from authorities such as the CDC, American Academy of Pediatrics and the NJ Department of Health to create a safe return plan that also places an emphasis on a valuable learning environment. She mentioned the community can expect a letter from her this week which will provide some insight into next year. Further details about next year will be provided in August.

Mrs. Signore also noted a focus and commitment to the very important agenda of student achievement. She mentioned new initiatives for this upcoming school year. The researched-based new math series called Big Ideas will be implemented. The adoption of a new grammar program to enhance student writing skills, accelerating a guided approach to reading, and increasing the use of data to customize instructional plans.

**BOARD SECRETARY’S REPORT**

Ms. Ippolito advised that an Engineer has been engaged by the district to perform a study to measure the distance to each elementary school for transportation eligibility. Once the roads are installed at the end of July, the study will be performed and the expectation is that the homes will be built in 2022.

Ms. Ippolito advised that the Referendum Bond Sale is scheduled to close on August 11<sup>th</sup>. She also indicated that the district received an S&P rating Letter and Report indicating that it continued to maintained an “AA” rating which enabled the district to obtain a 25-year loan with a 2.01% interest rate.

Ms. Ippolito asked Board members to complete their biographies and photos in order to have them posted on the district website as there are currently two positions up for election in November.

An Eagle Scout Project was presented before the board to set up Geocaches around town at historical sites and River Vale schools was requested to be part of this project.

Ms. Ippolito gave an update regarding the status of the Referendum projects. She indicated that the district is currently in the design phase and that meetings were being held with the Architects, measurements are being taken, sound systems and lockers were discussed. At this time, the district is planning to go out for bid on several projects in December and award the bids in January, 2022.

**Public comments:**

Ms. Ippolito, School Business Administrator/Board Secretary, responded that the District does not have that information at this time.

**Mr. Arthur White, 641 Cobh Road**: Mr. White stated that he found an issue with the Board’s current year Social and Emotional Board goal and using the word “equity” in it.

Ms. Signore, Superintendent of Schools, responded that this goal was formed using the State’s mandated language and that the intent is to give all students the tools to be on the same playing field.

**Ms. Jamie Alexander, 511 Dorchester Drive**: Ms. Alexander stated that she would like the Board to live stream the meetings as well.

**Mr. Matt de la Rosa, 712 Chalmers Court**: Mr. de la Rosa stated that he thinks Zoom is a better option for Board meetings and that he also had an issue with the definition of “equity” in the Board goals.

Ms. Signore, Superintendent of Schools, responded again that this goal was formed using the State’s mandated language and that the intent is to give all students the tools to be on the same playing field.

**Mr. Matt de la Rosa, 712 Chalmers Court**: Mr. de la Rosa stated that he did not think we are still in a pandemic. We need to put this in perspective and that the chance of a child dying from COVID is remote. Kids deserve to be in school.
