(hereinafter referred to as the “Architect”) as Architect of Record for preparing the Pre-Referendum Services for the River Vale Board of Education.

**WHEREAS**, the Business Administrator/Board Secretary has determined and certified in writing that the value of the contract is approximately \$79,700; and

**BE IT FURTHER RESOLVED** that the Board hereby appoints LAN Associates, Engineering, Planning, Architecture, Surveying, Inc. as Project Architect for preparing the Pre-Referendum Services for the River Vale Board of Education for a fixed fee of \$79,700, to include the scope of services listed below:

1. Phase 1 – Review of Cost Estimates: Cost estimates were previously developed for the various projects. LAN will review the estimates in more detail and update the cost estimates as required. LAN will estimate soft cost for the projects.
2. Phase 2 – Update Long Range Facility Plan: As part of the New Jersey Department of Education submittal process, LAN will need to update the Long Range Facility Plan to reflect the proposed capital improvement projects.
3. Phase 3 – Building Renovations/Schematic Planning: Schematic plans must be developed and approved by the New Jersey Department of Education prior to referendum vote. LAN would conduct the necessary field visits and develop schematic plans to meet the requirements of the NJDOE.

LAN will prepare the schematic plans and revise cost estimates based on the drawings that will be developed.

A schematic plan will be developed with sufficient details to allow filing with the NJDOE. Schematic approval will be required prior to bond referendum being presented to the voters. Schematic plans will include renovation plans, possible partial site plans. Filing will be required with the local Planning Board for advisory review for projects that affect the grounds.

LAN will prepare the NJDOE application and submit projects to the State for final schematic approval. A separate application will be required for each school or building that has renovations.
